



## **Limited Warranty**

The Kyoisha Company “Manufacturer” warrants to the original purchaser that this product as manufactured is free from defects in materials and workmanship. For a period of three 3 years or 2000 operational hours (whichever occurs first) from the date of purchase by the original purchaser, we will repair or replace, at our option, without charge for parts or labor incurred in replacing parts, any part which we find to be defective due to materials or workmanship.

### **Warranty is subject to the following limitations and exclusions:**

1. This warranty applies only to products which have been properly assembled, adjusted, operated and maintained in accordance with the instructions furnished.
2. This warranty does not apply to any product which has been subjected to alteration, improper assembly, installation and use of add-ons or unapproved accessories.
3. This warranty does not apply to damage which results from negligence, misuse or operating the product in an abusive or reckless manner.
4. This warranty does not apply to product failures which result from operating product without required maintenance and/or adjustment.
5. This warranty does not apply to parts subject to consumption through use unless found to be defective.
6. This warranty does not apply to failure caused by outside influence including, but not limited to, the use of unapproved lubricants, chemicals, additives or contaminants; or to weather, or storage conditions.
7. This warranty does not apply to normal “wear and tear” including, but not limited to; worn paint, scratches, dents, worn decals or similar damage.

### **Parts:**

1. Kyoisha "Baroness" will repair or, at its option, replace any part that is proven to be defective in material or workmanship under normal use during the applicable warranty period.
2. Any part replaced under this warranty becomes the property of Kyoisha "Baroness" Company, Inc.
3. All parts replaced under warranty will be considered as part of original product and any warranty on those parts will expire concurrent with the original product warranty.



### **To Obtain Warranty Service:**

The original owner must take or ship, at owner's expense, the "Baroness" Greens Mower and proof of original retail purchase date, to Kyoisha "Baroness" Company, Inc. Maintenance Department.

### **Emission Control System Warranty:**

The engine complies with the U.S. EPA and State of California emission regulations. Kyoisha "Baroness" provides the same emission warranty coverage for each engine sold regardless of manufacture. Unrecommended repair or replacement, unapproved modifications, improperly performed maintenance and installation of any replacement parts or accessories not conforming to Kyoisha "Baroness" specifications are not covered under this warranty and are not recommended.

### **Owner's Warranty Responsibility:**

The equipment owner is responsible for the performance of required maintenance as listed in the owner's manual. Kyoisha "Baroness" reserves the right to deny warranty coverage for damage resulting from failure to perform scheduled maintenance.

### **Limited Liability:**

This warranty does not apply to incidental or consequential damages and any implied warranties are limited to the same time period stated herein for our expressed warranties. This is a limited warranty within the meaning of that term as defined in the Magnuson-Moss Act.
